THIS YEAR, ALL REGISTERED VOTERS CAN REQUEST AN ABSENTEE BALLOT IF THEY ARE CONCERNED ABOUT COVID-19 AND DO NOT WANT TO VOTE IN PERSON. SIGNED ABSENTEE BALLOTS CAN BE RETURNED TO DROP BOXES WITHOUT A WAIT AT OVER 300 LOCATIONS STATEWIDE.

YOU CAN STILL VOTE IN PERSON IF YOU REQUEST AN ABSENTEE BALLOT.
AT THE POLL SITE YOUR ABSENTEE BALLOT WILL BE SET ASIDE AND NOT COUNTED.
